Minutes of June 16, 2015 RCRC meeting

The meeting was called to order by the president. All officers were present. A quorum was present. One guest was present.

The treasurer's report listed \$314.55 in income and \$626.72 in expenses for the past month. The general fund currently has \$2294.27, the money market fund has \$7680.72, and the memorial fund has \$891.76.

John Pieczynski gave the safety report which had no accident or injuries. Painting the propeller tips was mentioned.

John Williams gave the field report which discussed multiple minor repairs to the golf cart. The next repair will be the sprayer.

The Mike Wingo scholarship committee reported that brochures had been placed and the information had been on TV regarding the application for the AMA Camp. There was discussion regarding changing the dates for the application process but they were left intact so the winner could be announced at the pattern event in August.

A member wants to donate an AED unit for use at the field. Several issues were discussed related to that such as liability and exactly where it would be placed, whether indoors or out. It was voted to accept this gift.

UAH involvement with RCRC was discussed. It was voted to proceed with that by drawing up a document that would outline the relationship, essentially a memorandum of understanding to be approved by both parties.

Meeting attendance incentives were discussed. It was voted not to have pizza before meetings. It was also voted not to have door prizes. Programs will be announced in the newsletter.

Al Blair volunteered to fill the unoccupied office of vice-president for the remaining term.

The president pointed out that RCRC requires full AMA membership. A Park Flyer membership does not qualify.

A suggestion was made for an electric fly-in event. It was pointed out the we need CD's for events and that to be put in the AMA magazine they need to be scheduled 4 months in advance.

Improvements in the vertical take-off field were discussed such as two tables and crushed gravel around them.

The cost of those items will be investigated.

John Pieczynski gave the program which was on MonoKote surfaces.

Board Meeting Minutes July 7, 2015

1. UAH

A Memorandum of Understanding was reviewed and minor changes in the wording were made. That document will be sent to the officers after the changes are made. AMA will not insure UAH so they must provide evidence of equivalent coverage.

2. Auto accident

An auto accident at the field caused some damage to the fence and bench structures. That has been repaired. Thanks to Ron Lamon and Cameron Fears for getting those repairs done.

3. Camp AMA

Applications are slow to come in. The deadline is August 15.

4. Fireworks

An episode occurred at the field involving the use of fireworks that needed cleanup. The president will address this in the newsletter.

5. Membership

It was explained that the reason that park flyer AMA membership is not accepted is their lower level of insurance coverage. Club memberships after July 1 are half the regular amount.

6. Warbirds

Plans are complete for this event.

7. Field work

The large sprayer has been repaired with a new motor and pump. Information is being obtained regarding materials and supplies to improve the vertical take-off field.

Safety Report – The safety officer reported no injuries. He stressed that the most danger of personal injury is from a spinning propeller.

Ensure that spectators are behind the airplane when the motor is running.
