In AMA President Bob Brown's column in July's Model Aviation magazine, he mentions the AMA, and therefore we, have issues with the FAA regarding the pending legislation. He states: "It is becoming apparent that the FAA interpretation of the recent Congressional Act is not the same as that of the Academy. We have problems and every member of the Academy should realize this."

In another column in the same magazine, Rich Hanson, the Government and Regulatory Affairs team leader, indicates that Congress's confidence in community-based safety programming is not necessarily shared by the FAA. He states: "I can't stress enough how important it is that AMA members continue to validate the strength and effectiveness of our community-based program through unwavering compliance with the AMA Safety Code and related programs." For our AMA chartered club that at least means full compliance with the club's regulations and restrictions. The club can't afford to be the cause of an incident, national or otherwise.

The board needs your attendance at the July membership meeting. The first draft of the events for 2013 will be submitted for approval. There will be a program and door prizes.

Old Business:

The vote on the Bylaw change ARTICLE THREE, MEMBERSHIP, Section 3(b) was conducted and the change was approved. The Bylaws will be changed accordingly and distributed appropriately.

New Business:

Don Peck reminded everyone of the pylon race scheduled for this weekend and will appreciate help from volunteers late Friday to set things up.

There being no other business from the floor, the Program Chairman showed selected scenes from the Joe Nall Flyin DVD and held a drawing for door prizes with the meeting being adjourned at 7:45 PM.

July 2012 BOD Meeting Minutes

The July 3, 2012 RCRC Board of Directors meeting was called to order by the President at 7:00 PM.

All Board members were present except the Vice President. There were no guests attending.

The proposed event schedule for 2013 was discussed and agreed to by the Board. The schedule is published elsewhere in this newsletter.

The Statement of Certification recording the adoption of the June 19 Bylaw change was signed by the President and Secretary. Copies of the revised Bylaws will be made available to new members. The new Bylaws can also be accessed by the Membership at the rocketcityrc.com website.

A proposal by a member to place a recycling container in the pit area for collecting aluminum cans to generate revenue for the "Recycle for Rover" program at the Animal Shelter was unanimously approved by the Board. The membership will be requested to cooperate in this project by maintaining careful segregation of disposed items to the correct designated containers.

The meeting was adjourned at 8:15 PM.

At the Field

As previously indicated, this "At the Field" column will address general observations and anything else that comes to mind. If you have any ideas for a topic, notify any officer and they will pass it along to the newsletter editor.

The War Bird event was to have been held in June, but as previously reported, the contest director had a conflict with his work obligations and the event was cancelled.

The June Pylon Race event was held on 23 June with a total of 11 flyers participating. The contest director, Don Peck, has provided a summary of the event elsewhere in this newsletter.

With the high temperatures we've been experiencing over the last several weeks, I know the media has been reminding all of you of the many possible heat related injuries and their symptoms. We're not going to repeat them here, but we are going to nag everyone to be aware of the potential for injuries associated with high temperatures and to take all necessary precautions.

Complaint Area:

If you're thin-skinned, or don't like blunt criticism of yourself and others, you may want to skip this paragraph. Our Field Chairman, John Williams, spends a lot of time ensuring the field is maintained and the pit area is safe and serviceable. It is not his job, or anyone else's, to pretend they are your mother and pick up your trash or clean up your trash or clean up your mess. If you generate any waste or trash, put it in the proper receptacle. Broken parts, paper towels, crashed airplane residue, soda cans, water bottles, food wrappers, etc. go in the numerous trash cans strategically placed in the pit area. Smokers can place their cigar and cigarette butts in one of the three "Smokers Outposts" that reside in the pit area. If you're a smoker you know what they look like, use them. Five cigar and four cigarette butts, three paper towels, four food wrappers, and several balsa pieces thrown on the ground on one Saturday morning is not simply disgusting, it's unhygienic, disrespectful to everyone else in the club, and just plain lazy.



Flying Field Regulations

This month we'll continue our review of the Flying Field Regulations with the fifth rule:

5. Aircraft and Radio equipment inspections are required before the first flight of the day. Perform a radio ground range and controls performance check as a minimum requirement. First flights of repaired or new airplanes require inspection by other than the owner if there are other flyers or spectators present at the field. If possible, these test flights should be conducted when no other aircraft is in the air.

While this regulation is very straight forward, it's really four rules in one. The first part requires you to inspect your aircraft and transmitter before the first flight each flying day; as in a preflight inspection routinely conducted on manned aircraft. The daily radio range check is the second rule. It's also AMA National Model Aircraft Safety Code item B.2. for new or repaired aircraft. And, rather than present a technique here, which most of you could find fault with, consult your transmitter manual for your proper procedures. A thorough preflight and radio range check help ensure your aircraft will have as many landings as it has take-offs.

The third part of the regulation requires that first flights of repaired or new airplanes be inspected by someone other than the owner if there are other flyers or spectators present. Now this one is really tough to justify, especially since model aircraft pilots' egos can be just as big as manned aircraft pilots'. While no one wants to have their work "second guessed" and all of us know how to build and repair an airplane, it's a good idea. Even in

manned aviation an A&P's critical work is often inspected by an IA. Also, since we have this rule in place, if it isn't followed, and an injury or damage incident occurs, the club's and your own AMA insurance would likely be void for noncompliance. Since we are a very litigious society, insurance companies are always looking for ways not to pay. The fourth part of the regulation suggests that first flights of new or repaired aircraft should be conducted when no other aircraft is in the air. It's not so much that other aircraft will be in your way, but they can create distractions that prevent you from concentrating fully on that critical first flight. Other aircraft engines can prevent you from detecting tell-tale noises from your engine or control surfaces. If it's a busy day all that's required is that you ask the other flyers if you can "have the air" for a few minutes to conduct a first flight.
