You may have noticed that there are two new signs posted at the field and some old ones removed. This is part of the club's effort to make the field more inviting to newcomers.

April 2013 General Membership Meeting Minutes

April 16, 2013 General Membership Meeting Minutes The meeting was called to order at 7:00 PM by the President. All Board members were present.

A quorum was present.

One guest was present, Clarence Hauck, who runs an aerospace education program in Pensacola, Fla. and attended to make a presentation concerning a partnership with the local CAP unit.

The minutes of the March meeting were found to have an error. The last two paragraphs of the minutes were inadvertently omitted from the Newsletter. These read as follows:

"Another motion followed to amend the original motion to increase the donation to \$150. Both motions passed, making the vote for a \$150 contribution. Additional donations from the membership are welcome.

Since attendance at the meeting was so low, the program and door prize drawing were skipped to postpone until a later meeting and the meeting adjourned at 7:45 PM."

The Treasurer's report was given and approved as read. The President reported that he talked to Eric Enchelmayer about our runway condition. Eric noted our concern and will look into what the City can do to improve things and report back to us.

The VP advised the group that Aug 17 has been named National Aviation Day. The organizers have asked for some sort of fly-in on that day to raise money for the Wounded Warrior fund. Unfortunately this date conflicts with our event schedule. However the CD will take the opportunity of our War Bird event on July 27 to request voluntary contributions for this purpose.

The VP also commented at length regarding the growing number of States initiating legislation to control of UAVs and the potential adverse impact on our hobby. The AMA effort which is reported regularly in Model Aviation is a growing drain on AMA finances and results in less money available for other needs. An example was given where an incident at the University of Virginia resulted in the pilot of an RC controlled aircraft who acted in a blatantly irresponsible manner was fined \$10,000. Other examples of unfavorable publicity were given from Canada, Australia and other US locations.

The Members were advised that the VP is working on a draft of revised flying field regulations which has been

reviewed by the President and will soon be sent to the full Board for comment before being sent to an ad hoc committee of members for broader review and comment.

The Field Chair reported that an AnyLink transmitter adapter had been purchased to expand the instructors' capability. He also reported that the shed roof repairs were completed.

The Treasurer reported that the new windsocks have been received and will be installed soon.

A request was made from the floor to correct the list of flight instructors in the Newsletter

Peter Wick commented on the complaint from the SWDA on the first Saturday, which is the regular day each month for the public to drop off hazardous waste at the land fill entrance, that flyers were too close and were causing anxiety from some. Whether or not real, the perception of some that we were threatening their safety is what counts. All members should exercise caution on the first Saturday of each month until noon to avoid flying toward the SE corner of our flying site.

Bob Sorrells briefed the group on progress towards completing the on-line renewal/application capability and other Webmaster news.

OLD BUSINESS

A revote on the Club contribution of \$150 for the USA RC Aerobatics Team passed unanimously.

Jon Lowe's AMA Pattern contest proposal was accepted.

The President reviewed event schedule changes to be published in the May Newsletter.

NEW BUSINESS

Clarence Hauck made a presentation concerning establishing a partnership with the local CAP unit's aerospace education program. He left a package of material describing the proposal for review by the Club. Interested members are invited to a meeting with the CAP unit on April 22 at 407 Clinton Avenue E from 6-8 PM. Clarence will plan to attend our May meeting to see what our interest is.

The meeting adjourned at 8:00 PM.

The President was absent and the Vice President conducted the meeting which was called to order at 7:00 PM. All other Board members were present.

The subject of a partnership with the CAP was discussed. The Board will support the CAP initiative provided that sufficient interest is shown by the membership at the next membership meeting May 21. The CAP's Clarence Hauck will be at the meeting to answer questions about the proposal.
