### Club Meeting Minutes February 24, 2015

The February RCRC meeting was held February 24, 2015 at 6pm. The Pledge of Allegiance was used to open the meeting. Roll call showed all officers present except the newsletter editor. There was not a quorum present. Two new members and 2 quests were present. The minutes as posted in the club newsletter were tentatively approved as published.

The treasurer reported \$3306.96 in checking, \$7676.74 in money market, and \$891.03 in the memorial fund. The previous service charges on the memorial fund were refunded and the bank will continue to waive the service charges.

The safety report had no injuries. If ever there are any injuries, the incident forms to be filled out are in the filing cabinet. We were also reminded that observers should not be in line with the propeller when someone is getting ready to fly. There were no changes to report on the field.

Nick Damron gave an update on Drone Day, March 14. He ran through the list of companies planning to participate. Some will fly and others will have static exhibits. A representative of XF Aerials was present and they will have a static display. Pilot registration will be at 9am, and possibly an afternoon registration as well.

The Swap Meet will be on May 2, with setup the day preceding at the JC's building. Admission will be \$5 and tables \$20, with \$5 of that going for tax. There will be a snack bar. Help will be needed Friday afternoon. The field will not be closed during that time.

Members approved \$400 for Club Day: \$200 for prizes and \$200 for food which will be free to members and their guests. Members also approved \$240 for the War Bird event: \$20 postage, \$20 sanction, and \$200 for food.

The Mike Wingo Fund was discussed. Going to Camp AMA would cost \$795 plus transportation. The 2015 camp is full but we could reserve a slot for 2016. It sounds like experienced youngsters are attending. The age limits are 12-19. Al Blair and Don Philpott were appointed to make recommendations on selection criteria.

A request has been made to get the AMA to visit the club.

SWDA reiterates that no open flames are allowed on the club field. Due to a change at Parks and Recreation, we are waiting on the exact policies regarding vendors.

John Pieczynski has rewritten the document RCRC Rookie Tips bringing it more up to date. That document, the Bylaws, RCRC Flying Field regulations and the AMA Safety Code are to be provided as a new member Welcome Pack.

A program on using the Spectrum telemetry system was given by Dan Baldwin.





#### **Minutes of Board of Directors Meeting**

The Board of Directors of RCRC met March 3, 2015 with all members present. Preparations for Drone Day were reviewed. Media coverage will be coordinated with Nick Damron. There will be pilot meetings at 9am and 1pm. The appropriate licenses and permits will be obtained. The sound system was discussed. Instructors are Keith Carter and John Williams. The CD is Dan Baldwin assisted by Don Peck, Nick Damron and Al Blair. Also an update was given on the Swap Meet May 2. The subject of fuel sales was reviewed. Morgan Fuel sales will be contacted. There is nothing new from Parks and Recreation.


