- 4. John Pieczynski presented his proposal for a "Show Off" event. He requested \$320.00 for expenses. Event date to be finalized after AMA Sanction is received.

NEW BUSINESS

- 1. One of our members, Garret Smith, lost a white sailplane recently. He thinks it may be somewhere near/in the woods at the north end of the field. If you happen to find it (i.e., one of the FPV helicopter flyers⁽²⁾?) please let Garret or one of the Club officers know.
- 2. Board Member Nominations for 2017: Currently, no members have stated an interest. Write-in votes accepted at the next meeting. Keep this up and you'll be stuck with us for another year...
- 3. By-Law Change SECTION 3A, PASSED (23 in favor, 5 opposed):
 - a. Annual membership dues are now \$70.00

 - c. Non-member permits will be \$60.00
