# Field Regulations Proposed Addendums for Pets: Vote will take place at August club meeting.

Proposal 1: Pets are not permitted at the RCRC field.

#### Proposal 2: Pets are permitted at the RCRC field under the following conditions.

- Pets must be kept on a leash at all times.
- Pets must be kept under control by its owner at all times.
- Pets must be kept away from all equipment, aircraft, or persons that do not wish contact with the pet.
- All Huntsville City pet ordinances must be adhered-to at all times. <u>https://www.huntsvilleal.gov/environment/animal-services/pet-services/ordinance-and-license/</u>
- The pet owner is solely responsible for any issues that may arise as a result of their pet's behavior. This responsibility includes any potential financial liability. Examples include, but are not limited to, cost of re-imbursement for equipment or aircraft damaged by the pet's behavior and medical bills/compensation for an injury resulting from the pet's behavior.
- Violations to this policy or any pet incidents should be reported to the RCRC board of directors immediately.
- Disciplinary action permitted by club bylaws and field regulations may be taken against the pet owner and restrictions may be placed on the pet's activity in response to a violation, incident, or complaint. The RCRC board of directors will have sole authority to enact and enforce any actions that might be taken against the pet owner and the specific pet in direct response to a violation or incident.
- RCRC will not be involved in any legal discussions or legal determinations of liability or worth. It is the responsibility of those directly involved in an incident to negotiate a satisfactory resolution of the incident.
